What personal information do we collect?

When ordering or registering on our site, as appropriate, you may be asked to enter your name, email address, and phone number to help you get connected with us. As we are a global firm, we may also store your IP address to ensure you are handled by the appropriate team. Upon

becoming our client, we will also ask you to share your bank account details, taxation number, and identity proofs so we can proceed with the investment process.

How do we use your information?

We may use the information we collect from you when you register, make a purchase, sign up for our newsletter, respond to a survey or marketing communication, or use certain other site features in the following ways:

How do we protect visitor information?

Information is meticulously organized by category such that individual teams only have access to the section of information that they require to complete their tasks. Additionally, our organizational setup includes a Chief Data Officer, who oversees the management of client information that we handle, regularizes the culture of data privacy across the organization, monitors for anomalies and compliances, and also serves as the point of contact for all our stakeholders like clients or visitors who have questions about their data and the usage thereof.
